RESOLUTION TO CREATE STUDENT REPRESENTATIVE & ELECTORATE

WHEREAS, The Student Senate is the representative body of the students at Lorain County Community College; and

WHEREAS, The LCCC Student Senate is to foster a sense of goodwill among the student body including student clubs and organizations; and

WHEREAS, The LCCC clubs and organizations send representatives to the Student Senate general meetings in order to provide information and representation for their groups; and

WHEREAS, In the past the LCCC Student Senate has recognized a Student Representative in its official records as providing an electoral vote during Student Senate general meetings; and

WHEREAS, The position of Student Representative had been chosen by the attending student body by majority vote, after the selection of a meeting chair, to act as an electorate for all voting; therefore

BE IT RESOLVED THAT:

The Lorain County Community College Student Senate will amend its governing documents to include the position of Student Representative and insure the right of the Student Body in attendance at Student Senate general meetings an electoral vote.

BE IT FURTHER RESOLVED THAT:

The Student Representative is permitted to make motions and gather a vote for, against or in abstention from the student body in attendance of any issue that is brought forward; and

BE IT FURTHER RESOLVED THAT:

The Student Representative is not permitted to include themselves in the results of the electoral vote unless it is to break a tie; and

BE IT FURTHER RESOLVED THAT:

Each piece of electoral business, including selection of the representative and vote, must be completed within a reasonable amount of time.
